A RESOLUTION OF THE CITY OF JUSTIN, TEXAS PLACING CONSIDERATION AND ADOPTION OF THE 2022 TAX YEAR PROPERTY TAX RATE ON THE SEPETEMBER 13, 2022 CITY COUNCIL MEETING, TO ADOPT A 2022 TAX YEAR PROPERTY TAX RATE THAT WILL EXCEED THE NO NEW REVENUE TAX RATE AND THE VOTER APPROVAL TAX RATE BUT DOES NOT EXCEED THE DE MINIMIS RATE FOR THE CITY

OF JUSTIN, TEXAS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2022 AND ENDING SEPTEMBER 30, 2023; CALLING A PUBLIC HEARING ON TAX INCREASE TO BE HELD ON SEPTEMBER 13, 2022 AT 6 PM; REQUIRING PUBLICATION OF THE NOTICE OF 2022 TAX YEAR PROPERTY TAX RATE IN A NEWPAPER OF GENERAL CIRCULATION IN THE CITY; POSTING THE NOTICE ON THE CITY'S WEBSITE; AND PROVIDING AN EFFECTIVE DATE.

RECITALS

WHEREAS, the City of Justin, Texas is a Type A general-law municipality located in Denton County, created in accordance with the provisions of Chapter 6 of the Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, the City Council of the City of Justin, Texas will meet and determine the necessary appropriations required for Fiscal Year 2022-2023 on the 13th day of September 2022 and will determine it to be in the best interest of the citizens of Justin to propose a tax rate that will Exceed the No New Revenue Rate and the Voter Approval Rate, but not exceed the De Minimis Rate.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JUSTIN, TEXAS AS FOLLOWS:

SECTION 1. THAT The City Manager is hereby directed to place consideration and adoption of the 2021 Tax Year Property Tax Rate for the City of Justin, Texas on the City Council meeting agenda for September 13, 2022, at 6 PM at the Justin City Hall, 415 N. College Ave., Justin, Texas 76247.

SECTION 2. THAT The City Council hereby authorizes and calls a public hearing (Public Hearing on Tax Increase, as required by Texas Tax Code §26) to be held on September 13, 2022 at or after 6:00 p.m. at the Justin City Hall, 415 N. College Avenue, Justin, Texas 76247, at which the City Council shall, among other actions, hear and pass on any objections to the proposed property tax rate; and, upon the adjournment of the Public Hearing on Tax Increase, the City Council will consider an ordinance adopting a tax rate for tax year 2022.

SECTION 3. THAT The City Council hereby authorizes the City Secretary to publish Notice of Public Hearing on Tax Increase to be held on September 13, 2022, in the form prescribed by Section 26 of the Texas Tax Code, in a paper of general circulation in the City.

Background:

As discussed at the previous Council meeting, staff are recommending approval of all related documents for the notice of intention to issue certificates of obligation for a ground storage water tank and pump station. The anticipated amount required to fund the project is \$3.5 million based on updated construction cost estimates.

RESOLUTION NO. ____-22

A RESOLUTION approving and authorizing publication of notice of intention to issue certificates of obligation.

WHEREAS, the City Council of the City of Justin, Texas (the "City"), has determined that certificates of obligation should be issued under and pursuant to the provisions of Texas Local Government Code, Subchapter C of Chapter 271 (the "Act"), for the purpose of paying contractual obligations to be incurred for (i) the construction of public works, to wit: constructing, acquiring, purchasing, renovating, enlarging, equipping, and improving water and sewer system properties and facilities, including land and rights-of-way therefor, and (ii) professional services rendered in relation to such projects and the financing thereof; and

WHEREAS, prior to the issuance of such certificates, the City Council is required to publish notice of its intention to issue the same in accordance with the provisions of the Act; now, therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JUSTIN, TEXAS:

SECTION 1: The City Secretary is hereby authorized and directed to cause notice to be published of the City Council's intention to issue certificates of obligation in a principal amount not to exceed \$3,550,000 for the purpose of paying contractual obligations to be incurred for (i) the construction of public works, to wit: constructing, acquiring, purchasing, renovating, enlarging, equipping, and improving water and sewer system properties and facilities, including land and rights-of-way therefor, and (ii) professional services rendered in relation to such projects and the financing thereof, and such certificates shall be payable from ad valorem taxes and a pledge of the net revenues of the City's combined Waterworks and Sewer System. The notice hereby approved and authorized to be published shall read substantially in the form and content of **Exhibit A** hereto attached and incorporated herein by reference as a part of this resolution for all purposes.

SECTION 2: The City Secretary shall cause the aforesaid notice to be published (i) in a newspaper of general circulation in the City, once a week for two consecutive weeks, the date of the first publication to be at least forty-six (46) days prior to the date stated therein for the passage of the ordinance authorizing the issuance of the certificates of obligation, and (ii) continuously on the City's website for at least forty-five (45) days before the date stated therein for the passage of the ordinance authorizing the issuance of the certificates of obligation.

SECTION 3: It is officially found, determined, and declared that the meeting at which this Resolution is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Resolution, was given, all as required by Texas Government Code, Chapter 551, as amended.

SECTION 4: This Resolution shall be in force and effect from and after its passage on the date shown below.

NOTICE OF INTENTION TO ISSUE CITY OF JUSTIN, TEXAS, CERTIFICATES OF OBLIGATION

TAKE NOTICE that the City Council of the City of Justin, Texas, shall convene at 6:00 o'clock P.M. on the 27th day of September 2022, at its regular meeting place in the City Hall, 415 N. College Avenue, Justin, Texas, and, during such meeting, the City Council will consider the passage of one or more ordinances authorizing the issuance of certificates of obligation, in one or more series, in a principal amount not to exceed \$3,550,000 for the purpose of paying contractual obligations to be incurred for (i) the construction of public works, to wit: constructing, acquiring, purchasing, renovating, enlarging, equipping, and improving water and sewer system properties and facilities, including land and rights-of-way therefor, and (ii) professional services rendered in relation to such projects and the financing thereof, and such certificates shall be payable from ad valorem taxes and a pledge of the net revenues of the City's combined Waterworks and Sewer System. In accordance with Texas Local Government Code Section 271.049, (i) the current principal amount of all of the City's outstanding public securities secured by and payable from ad valorem taxes is \$16,335,000; (ii) the current combined principal and interest required to pay all of the City's outstanding public securities secured by and payable from ad valorem taxes on time and in full is \$18,651,694; (iii) the estimated combined principal and interest required to pay the certificates of obligation to be authorized on time and in full is \$6.712.550: (iv) the maximum interest rate for the certificates may not exceed the maximum legal interest rate; and (v) the maximum maturity date of the certificates to be authorized is August 15, 2052. The certificates are to be issued, and this notice is given, under and pursuant to the provisions of Texas Local Government Code. Subchapter C of Chapter 271.
