3. Review the Reatta Park Citizen Survey results

Citizen Bret Taylor reviewed the results with the board members as he organized the survey for the Reatta neighborhood. 58 households participated and 64% have school aged children. The top 3 improvements residents wanted to see are more covered seating areas or a large covered pavilion, a shade canopy over the playground and general playground updates such as lighting for safety, new equipment, more slides, repainting, etc. Members are interested in doing similar surveys for other HOA neighborhoods to get feedback.

4. Discuss Tree Canopy and Memorial Tree program

Member Steinbacher was going to give an update on the HOA's she had reached out to but was unable to attend the meeting. The discussed changes to the applications will be made and brought forward to another meeting.

5. Discuss changing Park Board meeting dates in October 2023.

Members discussed moving Park Board meetings from the first Tuesday of each month to the second Tuesday of each month. Members Amerine, Cuthbertson and Gallegos agreed to moving the meeting date but wanted to check with the members that were not in attendance.

2. Discuss implementation of Tree Canopy & Memorial Tree Programs Member Steinbacher reached out to multiple HOA boards and received feedback that they are excited about the Tree Canopy program. HOA boards would be willing to simplify the process so citizens that live in an HOA wouldn't have to apply thru their HOA and thru the city if they want to participate in this program. Members requested that the tree canopy application have the verbiage added

Member Taylor motioned to approve the applications with the amendments Seconded by: Member Steinbacher

that specifies that the homeowner is responsible for tree planting.
